GENERAL RULES: A COPY OF YOUR HORSES REGISTRATION PAPERS **MUST** BE ON FILE WITH THE SHOW SECRETARY OR ACCOMPANY YOUR ENTRY FORM. NO PAPERS NO SHOW!!! PLEASE ALSO INCLUDE THE SIGNED WAIVER WHEN ENTERING. **NSS STALLION NOMINATIONS ARE DUE AUG 1ST \$200 OR WITH LATE PENALTY AUG 2-22ND \$300** NSS CONTESTANT ENTRIES DUE by AUG 19th LATE PENALTY AFTER AUG 21st NRCHA ENTRIES ARE DUE BY NOON AUG 22ND OR WITH LATE PENALTY TO 7AM EACH DAY OF SCHEDULED CLASS. Late NRCHA entries will be drawn up last in the cutting, first in the dry and fence work according to NRCHA rules. ALL HORSES WILL RUN IN ORDER DRAWN! **All NRCHA RULES APPLY!! BOTH OWNERS AND RIDERS MUST BE NRCHA MEMBERS IN GOOD STANDING FOR NRCHA CLASSES. Contestants are responsible for double checking the draw and making sure they are entered in the appropriate classes. After the class has started, entries are according to the draw.**

Grade horses must now be registered with NRCHA prior to showing. (rule 1.1.4). Fee for the license is \$25 / \$10 to transfer an existing license.

WAIVER

All participants must sign before showing.

Pursuant of NRCHA Rulebook 12.1.15 "By my signature below I hereby acknowledge that I meet the criteria for eligibility to compete in the classes entered according to the guidelines set forth in the NRCHA rulebook." This is to insure that competitors are aware of the criteria for the different classes in which they are indeed eligible to compete."

Acknowledge of risk: The undersigned acknowledges that the participation in horse events, with a contestant, an employee, or volunteer exposes the participant to a substantial and serious risk of property damage, personal injury or death. The undersigned expressly acknowledges that his/her participation in the event will involve such a hazard.

release of sponsors: The undersigned hereby release all sponsors from liability and any and all property damage, personal injuries or other claims arising from the undersigned's participation in the event, including those known and unknown, unforeseen future or contingent.

covenant not to sue: The undersigned covenants that the undersigned shall not now or at any time in the future, directly or indirectly, commence or prosecute any action suit or other proceeding against the Elko County Fair sponsors of the event (or their officers, directors, employees, agents, or affiliated including but not limited to the Elko County Fair or any other sponsors) concerning, arising out of, or related to the actions, cause of actions, claims, and demands hereby waived, release or discharged by the undersigned.

Assurances: The undersigned has full power, authority, capacity and right without limitation to execute, deliver and perform this release.

Binding effect: This release shall be binding upon the undersigned and undersigned's spouse, legal representatives, heirs, successors and agents.
