Pooch stated we need to put cameras on those windows again, so they can delay for more betting time, look into putting in cameras for the stewards to watch windows on east end of grandstands. Walter will contact Steve to order the harrow.

He would like to run an Adult Halloween Ball in the exhibit hall to bring in a lot of money spend money on decoration and maybe a bartender or two. JJ requested some power strips put in the announcers stand and he is getting a swamp cooler installed in there.
