## Minutes:

Tony Buzzetti moved to approve the June 13, 2018 meeting minutes as presented. Dawn Leyva seconded, all approved.

## **Public Comment:** Information Item

Aaron Means stated Winnemucca is having a huge barrel race same weekend as us and they would like to have the Elko County Fair barrel race on the first weekend Saturday August 25<sup>th</sup>.

Jan Peterson would like on to run an event during the branding event on Sat., the main weekend of the fair set up in the paddock area selling boards to brand for a fundraiser. This will be for the Great Basin Cowboy Gear Museum. \$300.00 per iron whether they are registered or not it will also have a plaque for each brand stating which family or person did it. Everyone is welcome to join in. They are doing a publicity campaign to get more people too. They will have their own pot going and doing it on the parimutuel area.

## Action Item

Dawn Leyva didn't realize the windows would cost about \$35,000-\$40,000. Shippy would get the arena for 4 years and put their name on top of the announcers stand. Discussion on the opportunities for them for their donation. Must talk to them for what the sign would be and a more permanent sign.

## Old Sheriff's Posse Building: Action Item

JT had Judge Nancy Porter contact him wanting the old Sheriff's Posse trailer for a nonprofit classroom counseling juvenile's during drug court. It will cost about \$50-60 thousand dollars to make that updates and she is trying to get grants to repair it.

- Home Arts-Tera Hooiman needs direction and she will get with Sue. Wants to do the family fun stage and solicit local bands/talent for the Elko's Got Talent for the fair weekends.
- Stockhorse Chairman-Tony Buzzetti-we are finishing the stockhorse book and will get it to the printer.
- Stockhorse- John Henry Roderick will get the muley roping stuff to JJ soon.
- Racing- Steve Mc Dermott reported that Terry wants to come do the stalls again. Steve felt JT could do it but will investigate it further.
