Concert 2023 Elko County Fair: For Possible Action Item

Kim McKnight talked about the group The Frontmen for next year. We must decide dates and whether the other stuff will be available, lighting, sound, and stage. It will be \$25,000.00 for just the group. They will throw in the opener for free. The Board was looking to have the concert on Thursday August 24th. Discussion on the days and what would work best and if we must change our schedule. Sell tickets for around \$45 each and if the stage is in the arena, then it would allow for the box seat people to have VIP tickets with their box. There is 30-60 days for the contract and pay the down payment. Cord would come back too. Giovanni stated we probably need to pursue this now and get the date held. Kim would call and get the date held and bring hard numbers to the October meeting.

Giovanni made the motion to set the concert date Thursday August 24, 2023, have Kim McKnight work to get the Frontmen group set. Justin McDermott seconded all approved.

Racing-Stakes Race Reports, Race Announcer, Track Stewards, Paddock Weigh off judges, Stalling, Registry, and Starting Gate: Action Item

Giovanni will cover the parimutuel bank and will get with Yolanda on that. Weigh off judge will be Randy Munger when Giovanni can't do it. The starting gate Les can't do the last weekend and JT put a screen door on the race office and change things on the way they enter. Terry won't enter the horses, and this will clean it up a little bit. Starting gate looks good and has a new logo. Alfonso wants 9 loads of sand. John Petti is coming to announce. JJ reported on the stake's races. Dr Winchell called and discussed the drug testing on the races with Brian McIntosh, last year they did 81 samples. They are doubling the price of the urine and blood tests. They can absorb this additional cost right now, but they are going to have to get the approval for the raise in the cost of testing with the NV Gaming. Nothing else to report.

Losing Ticket & Cowboy Bar: Action Item

Karen Hoem is the manager again this year and has everything ordered and ready to go. Liquor license is done, and health certificate is done. Giovanni Puccinelli made the motion to do the losing ticket again. Justin Mc Dermott seconded all approved.

Grounds Reports: Action Item

Grounds Manager JT Taravella got the propane coming Friday. Paint for the kids branding. All the machines are a go only 3 buggies this year. The sound parts for the arena are coming. George Kleeb donated flowers and would like the donation on the flowers. Has prison guys and community service for cleanup. Tony and John looked at the stock pen area and using new lines of water for dust control. Nothing else to report.
