Elko County Fair Board Chairman Tony Buzzetti called the regular monthly meeting to order at 5:29 p.m.

#### Minutes: Action Item

Meeting Minutes from the Regular monthly meeting November 16, 2022. Justin McDermott moved to approve the meeting minutes as presented, Roy Elsner seconded the motion, all approved.

#### Board, Staff & Committee Appointments: Action Item

John Ross moved to make the motion to keep the Chairman and Vice Chairman the same as last year. Justin McDermott seconded all approved. The executive committee we would have chairman, vice chairman and Justin McDermott as the third. Roy Elsner made the motion to keep them the same John Ross seconded, all approved. #### **Vendor Contracts:** Action Item

Changed the event from 5 days of sales to 4 days of sales Fri-Mon, changing the pricing to reflect the less day cost. Included the option to buy tickets to the fair at a discounted rate and purchase when they turn the contract in. Updated the times and dates to 2023. Cori Rainwater made the motion to approve the changes to the vendor contract. Justin McDermott seconded all approved.

Concert-August 24, 2023, the previous band backed out and we are working on getting someone else. Chip Stone recommended sending a deposit for the sound or we will lose them. Chip will work on it this week. Discussion on different options. Chip contacted and maybe have Mark Chestnut or Blackhawk

On the 26<sup>th</sup> we would be about 4:30 too. Do we run the kids on the 1<sup>st</sup> yes, we will run them that day. Calcutta sometimes runs a long time and maybe will not be effective.
