The local Youth Equestrian Development Association (YEDA) would like permission to coordinate a 50/50 raffle at the 2023 Elko County Fair. Money raised will pay for expenses associated with hosting two horse shows in the 2023-2024 riding year as well as attending the YEDA National Championship in McDonald, Tennesse, on May 30 - June 2, 2024.

Wells, Nevada, is home to the only Nevada chapter of the Youth Equestrian Development Association (YEDA), a fast-growing national organization helping youth ages 9-17 develop horsemanship skills. The local chapter, High Desert Horsemen, includes ten youth from Wells, Elko, and Spring Creek.

Laurel Wachtel organized the local chapter in 2021, to expose youth to horsemanship opportunities including scholarships to join college riding teams. Wachtel is a two-time AQHA Professional Horseman World Champion and has over 30 years experience coaching students in western riding.

Team members participate in regular riding lessons, team practices, clinics and horsemanship events. Riders compete in classes at the elementary (4-5 grades), junior high (6-8 grades) and senior high levels (9-12 grades). Riders earn points for managing horses through patterns of walking, trotting, loping, turning, and backing. Unique to YEDA, riders draw club horses to ride at events. This builds riders' skills and confidence with not only their own horses but also other horses. Through YEDA members become more competitive for college scholarships as well as gain useful skills to advance their success in future careers and life-long endeavors.

YEDA is open to youth in 4th through 12th grades and may include riders with disabilities. Team members take lessons, attend team practices, and show at local horsemanship events. Riders do not need to own a horse to join, but need to have access to one for their lessons. The YEDA season runs August to May with the national competition held annually in McDonald, Tennessee.
