# SPECIAL AWARDS



## THE J.M. CAPRIOLA'S OUTSTANDING STOCKHORSE TROPHY

To be awarded to the Outstanding Stock Horse at the Fair, the winner is to be determined on a points accumulated basis. Points will be awarded in the following classes at the Fair: Co-Ed Branding, snaffle bit, hackamore, two rein, Nevada cattle working, and all bridle classes, excluding Women's and Open Branding Class and Women's Branding. Points will be awarded through fifth place in each class (5,4,3,2,1), with the horse accumulating the most points being the winner. Stock Horse rules apply in all cases, ties broke by Stockhorse rules. Owner or rider must declare horse is being roped on in the branding when entering on entry form.



## BEST OUTSTANDING RIDER

This will be awarded to the Nevada resident who is the rider earning the most money during the Elko Co. Fair in the snaffle bit, hackamore/two rein, cattle working, Champion Nevada Cow-horse, and the Ranch Horse Class. (Not eligible classes: womens' class). All riders must own the horse they're showing or be owned by immediate family member. Proof of ownership required. Awards donated by J.M. Capriola and Elko County Fair Board.



## NOTE ABOUT BRANDING PARKING

See Schedule for Times and Dates

Parking in-field is only available after the last races are run. Only entrance is on Golf Course Road. If parking in the in-field, you must be out by midnight.

# UPDATES:



- All Stockhorse and branding entries are now due AUGUST 25TH BY 5:00 PM. Entry forms are available on the website and can be emailed or texted to 775-397-2769. Branding entries can be entered directly on the website.
- \$100 late fee for all classes. If entered late, you will run last in herd, 1st in rein and fence work.
- Change in residency rules on the below listed classes. These classes no longer require Nevada residency and are open to any level of rider limited to one entry but if the horse is owned by a Nevada resident, you may enter 2 horses.
  - Open Snaffle, Nevada Open Hackamore / Two Rein, Ranch Horse class (this class is limited to 25 entries only, 1 entry per rider).
- There is a schedule change with the Ranch Horse class. It will run entirely on Friday. Please see the schedule page for more information.
- \$1,000 added money to each Stockhorse Class.

# RULE CHANGES AND CLARIFICATIONS:



- There have been many changes in class scheduling and rules. Please see schedule on page 7.
- All entry fees must be paid at time of entry, no exceptions.
- Payment of entry fees by a third party or single team member shall not release anyone in the event of insufficient funds. All individuals or team members are in bad standing with the Elko County Fairboard/Stockhorse Committee until all funds are paid. Horse Registration papers must be provided or a vet statement of age. Non-Pros must have proof of ownership.
- All participants showing in roping classes (or Champion Nevada Cowhorse and Ranchorse Class) at the Elko County Fair must have a rope on their saddle. Rope must be tied to the fork (front) of the saddle. Rope may not be tied behind cantle (back) of saddle. This rule does not apply to the Young Buckaroos 8 & Under and the Junior Riders 9-12 classes.
- All Hackamore, Two Reined and Bridle Classes will call for fence cow immediately after dry work. The Hackamore/Two Rein class is now combined with two divisions, Non-Pro and Open.
- Classes that are age specific headgear: Non-Pro Cowhorse, Senior Non-Pro Cowhorse, Champion Nevada Cowhorse, Ranch Horse Class, Junior Riders 13-16, Cattle Working and Women's class
- Stalls and pens for the Elko County Fair Stockhorse participants are on a first come basis. Stalls are \$20/day, Pens are \$10/day
- Revolving trophies to be won three times to retire.
- Youth and Miner's Branding Entry deadline August 21st by 5pm. Drawpot enter on the day from 9-10am entry time.

The Elko Co Fair Board would appreciate it if the stock horse contestants would be watchful when entering and crossing the track, because of the race horse activity. Please exercise your horses in the warm up arena. Lets keep the track in good shape to keep from packing it down, absolutely no vehicle will be allowed in the infield except on designated days. Thank You.

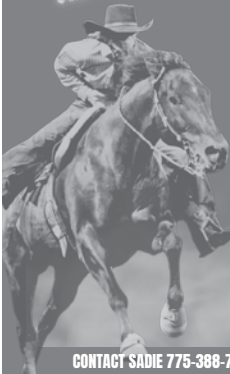

# IMPORTANT RULES

1. **ELIGIBILITY** of horses (replaces the No Brand, No Papers, No Show rule): To be eligible to show in the Non-Pro Stock Horse Classes, NV Cattle Working, Women's and Champion NV Cowhorse Stock Horse Classes, the horse must be owned by a Nevada resident (who must show a Nevada Driver's License) at the time of showing. Burden of proof of Nevada ownership is the contestant's responsibility and must be made before the class starts. Proof will be accepted at the discretion of the Stock Horse Committee. Residency is based on an individual's predominant and principal home. All other eligibility questions will be determined by the Stock Horse Committee. The Open Snaffle, Open Hackamore/Two Rein, Ranch Horse classes are open to anyone for entry, no Nevada residency required.
2. **ENTRIES CLOSE AND MUST BE PAID AT 5 PM FOR STOCK HORSE CLASSES. BRANDING ENTRIES CLOSE 5 PM ON SUNDAY, AUGUST 25th.** Entries must be paid for at time of entry, no exceptions. Horses may be inspected by a representative of the Stock Horse Committee prior to showing. All horses must be sound. Any horse can be disqualified by the committee. Any horse not entered, ownership proven and inspected in accordance with these rules prior to any contest shall not be allowed to show.
3. **The following provisions regarding conduct shall apply to any Elko Co Fair Board approved show. The responsibility for reporting violations or conduct rests with, but is not limited to, show management, Elko County Fair Board Directors, officers, officials and the judges. It will be the responsibility of the contestants who have complaints to file these complaints with the Secretary no later than 48 hours prior to the show. The Elko County Fair Board and Elko County Fair Board Stockhorse Committee will keep the names of the person or person's filing the complaint anonymous. Unsportsmanlike conduct will not be tolerated. Unsportsmanlike conduct shall be defined as any action of disrespect, deceit, fraud or intimidation directed to judges, show management, the Elko County Fair Board or other exhibitors, spectators, or sponsors. Violations will be brought before the Elko County Fair Board and or the Elko Co Fair Board Stockhorse Committee and a hearing may be scheduled before said committee for possible disciplinary action or suspension. A contestant shall not intimidate, or attempt to intimidate a judge. The penalty for violating this subsection will be an immediate disqualification from events. Any member or team may be disciplined, placed on probation or suspended from the Elko County Fair or Elko County Fair Board sponsored events. The decision of the Elko County Fair Board Stockhorse Committee or other involved committees shall be recommended to the Elko County Fair Board of Directors and the Elko County Fair Board Directors decisions shall be final and binding on all parties. Any person or persons who threatens or actually inflicts bodily harm or injury to another person or persons based upon that person or person's actions, conduct or decisions, shall be suspended from the Elko County Fair or Elko County Fair sponsored events for a period of not less than one (1) year or can be suspended indefinitely. No person or person's**

**IMPORTANT RULES (CONTINUED):**

shall make a derogatory remark, nor take or threaten to take adverse action against an Elko County Fair sponsor, its agents, servants, or employees, relating to any manner to the sponsors involvement with the Elko County Fair or an Elko County Fair sponsored event. Any person violating this rule is subject to disciplinary action and is also responsible to the Elko County Fair Board for any loss or damage caused by a violation of this rule.

- 3a. In case of dispute, the team puts up \$50 to the stockhorse secretary; upon receipt the stockhorse committee will hear the complaint for a decision. If the committee rules in favor of the team the money will be returned if not the money is put into the pot. Any person desiring to file a complaint regarding any alleged violation of the rules may do so within an (1) hour of the completion of the event. (An event being a stockhorse class and eliminations semi finals or a finals). Rules of the judge and stockhorse committee are final**
4. All horses will be considered born January 1, the year they are foaled. A horse shall turn another year older on January 1 of each year thereafter.
5. JUNIOR RIDERS: For all Junior events birth certificates may be asked for at time of entry. Your age will be your age on the day you show.
- 6. Anyone in the arenas must dress in western attire, which includes western hat.**
7. Any horse which enters the arena must stay in the arena.
- 8a. A rider may show only 1 horse per class except for the Open/Non-Pro Snaffle, Non-Pro Hackamore and Two Rein. See individual classes for rules.
- 8b. Non-Pro Classes: Horse must be owned by rider, immediate family member (spouse, child, parents or grandparents) or horse can be owned by the ranch the rider is employed by. Verification must be given at time of entry. A Non-Pro is defined as a person not receiving remuneration directly or indirectly for showing, giving lessons, clinics or assisting in the training of a horse for remuneration.
- 8c. Any horse shown in Stock Horse classes may only be shown by that same rider throughout the fair, except as stated for Young Buckaroos, 8 and under, and Junior Riders 9-12 if ridden by a brother or sister, but no adults.
- 8d. All horses in the youth classes, Young Buckaroos 8 & under and Junior Riders 9-12 must be shown in standard bridle equipment.**
9. In appreciation of our sponsors, the ECFB strongly encourages all contestants to participate in Award Ceremonies following all classes. Livestock members who have a conflict should see a Stock Horse Committee member.
10. No one is allowed in or around the judge's stand, except officials and donors. Others must seek special permission from Elko County Fair Board. Donors will be permitted only during events they are sponsoring.
11. The order of go and the pen numbers in the branding will all be drawn. In the cowhorse classes, the Ratliff draw system will be used. The order of go will be drawn and the first section will start with number 1, the second section will start with a number 1/3 of the way down the list, the third section will start with a number 2/3 of the way down the list etc.

### **IMPORTANT RULES (CONTINUED):**

12. Tie scores will be broken by the fence score. In the event of fence scores tied, tie will then be broken by herd score then to dry work.
13. Unofficial scores will be announced after each horse works.
- 14 . **The judge's decision is final. No video review will be allowed.**

## **STOCK HORSE CONTEST**

**Entries:** Entries close and must be paid at 5:00 p.m. on August 25th. If any horse is shown in any Stock Horse Class that is not eligible, both horse and rider will be barred from all contests in the Elko County Fair and must relinquish all winnings. Original papers or other satisfactory evidence of ownership is required prior to payment of awards.

Any bridle horse-rider combination winning in any class except the Young Buckaroos, Junior Riders 9-12, Junior Riders 13-16 cannot be entered in the same class the following year (sitting out one year). See specific class. The decision as to whether a horse and rider is eligible or not will be decided upon by the Stock Horse Committee.

**Revolving trophies must be won three times by an individual rider in order to be retired.**

### **RULES FOR JUDGING**

#### **Showing Stock Horses**

#### **When Worked on Cattle**

##### **Rule 1. POINTS.**

Horse shall be judged on:

1/3 herd work

1/3 single cow

1/3 reining pattern

Horse may be judged for soundness and conformation before entering the arena.

##### **Rule 2. APPOINTMENTS**

Horses shall be shown with stock saddle, without tapaderos. Bit standards: A spade bit or a bit having the following characteristics must be used in all bridle classes (including youth). Said characteristics shall be: one with an unbroken bar mouthpiece with one inch or higher port measured from bottom of the bar to the top of the port. There must be an operable cricket inside the port of the bit. The diameter of the bar must be a minimum of 3/8 inch. The cheeks must be connected at the bottom. The overall length of the bit shall not be longer than 8 1/2 inches. Optional tongue release shall not exceed 3 inches in width. Braces, copper port cover and/or having copper smoothly inlaid in the mouthpiece are optional. Snaffle Bits shall be either "D" or ring type, no larger than 3 inches in diameter on the inside of the ring. They must have a broken mouth piece being a minimum of 3/8 inch in diameter from the corners, with a gradual taper ending in no less than 5/32 of an inch of the middle of the bit. A leather curb strap is to be used. Reins are attached above the curb strap. Breast collar is acceptable. Bosal, martingale, or tie down prohibited; no wire, chain or other metal or rawhide device may be used in conjunction with or as part of leather chin strap. If a curb strap is used it must be flat and 1/2-inch or wider with no knots. ***Bridle may be inspected at anytime by judge and stockhorse committee during event.***

## **STOCK HORSE RULES (CONTINUED):**

### **Rule 3. INSTRUCTIONS TO RIDERS**

In bridle classes, only one hand may be used on the reins and hand must not be changed. Hand to be around reins. Fingers between reins not permitted. Spurs or romal shall not be used forward of the cinch. At all times while horse is in motion the rider's hands shall be clear of horse and clear of saddle in accordance with judge's instructions. (It is suggested that judge instruct exhibitors to keep hands clear of saddle except at such times as it is necessary to use them to prevent a fall.) If any rider bleeds his horse by bit or spurs, he may be disqualified by the judge. As many riders do not use spurs, moderate use of romal is permitted. Excessive use will penalize or disqualify rider. Breaking of a curb strap will warrant disqualification. Rider may be disqualified for not following judge's instructions. A rider must not jerk or abuse his horse in any manner, in the arena at any time, as it sets a bad example for the Junior Riders and spectators. If a rider is caught abusing his animal in any manner, he will be disqualified by the Stock Horse Committee or Judge.

This applies to all contests at the Elko County Fair.

### **Rule 4. WORKING**

Judge will give instructions and assign pattern at the beginning of each class.

### **Rule 5. FAULTS**

***The following characteristics are considered as faults:***

Switching tail, hard or heavy mouth;

Nervous throwing of head;

Lugging on bridle;

Halting or hesitation while being shown (particularly while being run out);

Indicating anticipation of being set up, which is characteristic of an overtrained horse.

***The characteristics of a good working horse are:***

Horse should have good manners.

Horse should be shifty, smooth and have his feet under him at all times. When stopping, hind feet should be well under him.

Horse should have soft mouth and should respond to a light rein, especially when turning.

Horse's head should be maintained in its natural position.

Horse should be able to work at a reasonable speed and still be under control of the rider.

### **Rule 6. FALLS**

The fall of a horse and/or rider while being shown in reining tests shall eliminate the entry in question. If a fall occurs while the horse is being worked on cattle, or if a horse falls from wet or slippery ground, elimination is at the judge's discretion.

## **Suggested Procedure For Showing with Cattle**

*The Elko County Fair Board has adopted the foregoing rules for judging stock horse classes.*

In working cattle, the contestant is required to work at least 2 head. The contestant shall be asked to cut animals from the herd and work them back and forth in front of the holders in such a way as to demonstrate the horse's ability to dodge, duck, and to keep the animal from returning to the bunch. The back fence rule will be used for all classes. 2 1/2 minute limit on herd work.

### **STOCK HORSE RULES (CONTINUED):**

Contestants are to provide their own turnback help and are limited to two turnback men and two herd holders. All other riders will be required to stay behind the judge's pickup. Stock Horse entries may be requested to act as turn back men. Then if the judge desires final work, the judge may pick his own turn back men.

A single cow will be worked in the arena at the direction of the judge.

Horses must be serviceably sound, in good condition, and of stock horse type; blemishes on account of accident (for example, wire cuts) not to be counted against the horses. Entries to be open to stallion, mare or gelding without discrimination, unless otherwise specified, may be passed for soundness before entering arena, by veterinarian. Any traces of dope found with horses in these classes will be tested, and horse, rider, and owner automatically barred.

## **SNAFFLE BIT - NON-PRO CLASS**

*Herd work for both snaffle bit classes is at 8:00 a.m., Cow Work Friday 8am*

\*Rules for the Non-Pro Snaffle bit class are the same as the Open Snaffle Bit Class: Any rider showing in the Non-Pro cannot show in the open snaffle.

No limitation or amount of horses one rider can show provided it is owned by an Elko County resident. You can also show one other Nevada owned horse.

This is a non pro class, all non pro riders must own the horse they are showing or horse must be owned by an immediate family member (spouse, child, parents or grandparents), or a ranch where rider is employed. Proof of current ownership required. A non-pro is also defined as a person who is not currently receiving remuneration directly or indirectly for showing, giving lessons, clinics, or assisting in the training of a horse for remuneration.

**\$200 entry fee** - 45% held back by the Fair Board for Stock Horse expenses, purse to be divided: 40% to the winner, 30% to second, 20% to third, 10% to fourth.

## **OPEN SNAFFLE BIT**

**Thursday 8:00 a.m. With Non-Pro Snaffle Bit.**

**Entries close August 25th 5 p.m. • Late Fee \$100**

*Herd work will be with the Non-Pro Snaffle. Rein work will follow after the Non-Pro Snaffle rein and cow work will run Friday morning.*

Stock Horses showing a five-year-old mouth or younger. For horses just starting, that have never been in any bit other than a snaffle bit. Horses must meet eligibility requirements. Two hands can be used. A snaffle bit horse should be worked with a light hand. Horse must be worked with a snaffle bit, **and the bit must have a leather curb strap**. If reasonable proof is produced showing that the horse has ever been shown with a bridle, the horse will be disqualified. Horses to be shown in the same manner as in the bridle class, as in arena work and cattle work. Horses may be mouthed before showing.

We want to focus on the importance of a well-trained ranch horse, used for everyday work.

**Eligibility:** This class is open to any level of rider, no residency requirement. Horses must be owned by the rider, a family member or owned by the ranch they currently work for. Horses entering this class must NOT have any recorded money earnings, in the NRCHA, NCHA, NRHA or AQHA. Headgear for this class must be traditional head gear, snaffle bit, hackamore, two rein or bridle. However, headgear is not age-restricted for this class. For example, you may ride an 8 year old snaffle bit horse. Horse is no longer eligible if they have won money in Stockhorse classes or won/placed in the Ranch Horse Class.

**Description:** This will be a 3 event class: herdwork, simplified reined work and fence/rope work. Reined work for this class will be simple pattern with 2.5 spins each way, loping 2 circles each direction, and a simple lead change (breaking to a trot to change leads will not be penalized). For the fence work portion of this class, the horse and rider will box the cow on one end. After boxing the rider, will rate the cow down either fence past the center marker and turn the cow, making one turn each way. Then, rope the cow with a legal head catch. Two loops. Five point penalty for missed first loop, 0 score if not roped. 60 sec time limit.

Friday & Saturday night there will be available parking in the infield after the last races. Friday and Saturday after the races. All vehicles have to be removed by midnight. NO EXCEPTIONS!!

### **1. ENTRIES:**

- a. Youth Branding, \$15 Each; Youth Division 7-10, 11-14 Senior Division, \$100/Person; Age Limit 60 Years and over Drawpot Branding, \$25/Person; Ages 14 Years and Older Open Branding ENTRY FEES: \$500/team - \$125 per person, 45% stock and office charges. Women's/Co-Ed Branding ENTRY FEES: \$480/team - \$120 per person.
- b. Women's, Co-Ed, Senior & Open Entries close on Sunday, August 25th at 5:00 p.m. Entry fees must be paid at time of entry NO EXCEPTIONS!! No team will be on final list of entries until paid in full!! NO EXCEPTIONS!! Youth and Miner's Branding entry deadline Wednesday, August 21st. Miner's Branding must provide proof of working at a mine to enter.
- c. Each entry must contain all team members' names and contact information (co-ed must also contain 2 males and two females). Two substitutes will be permitted per team; and must be listed on entry form however; Stock Horse Secretary must be notified of ANY substitutions prior to the start of the eliminations. Youth and Drawpot branding will be paint iron.
- d. Each person limited to enter only one team in each division (women's, open, and co-ed).
- e. Absolutely no substitutes will be allowed during any heat that has commenced. If team is unable to complete the heat, the team will be given a no time. A team in any division (women's, open, and co-ed) of the branding contests may complete a heat with three members as long as the remaining participants are performing their function only once. For example, a team can finish the heat with one ground crew as long as ropers and ground crew have changed.
- f. In all team divisions (women's, open, and co-ed) all contestants starting the contest must finish the contest. Only in the event of injury or personal crisis will an alternate be allowed to finish the contest, and only upon approval of the stockhorse committee.
- g. Drawpot - each team will be drawn with 4 team members, 30 team limit. Can enter up to two (2) times.

**2. TEAMS:** Each team will consist of a four (4) person crew: two (2) to rope the first set, the other two (2) on the ground. Team members will then exchange places for last set. Youth and Senior will not change places.



## **WORLD CHAMPIONSHIP BRANDING (CONTINUED):**

**3. CALVES** will be furnished by the Elko County Fair Board.

**4. GROUND RULES:** Each team will head and heel a designated amount of calves. Open Branding will head & heel six (6) head of calves. Senior and Youth will head and heel two (2). Women's, Co-Ed, Drawpot and Miner's will head & heel four (4) head of calves. No tie downs allowed.

a. Slick saddle horns only; no rubber, rosin or foreign ingredients or objects; if found, disqualification from the event. **ONLY YOUTH ALLOWED TO USE RUBBER ON HORSES.**

**b. Legal catches are head only for Open, Womens, Co-Ed and Senior (catch is not considered illegal till header dallies), for all other catches the rope must be removed or fished clean by roper at the discretion of the team, and the animal must be roped again. No front legs allowed in any event. Youth: horns, half head and front leg are legal. Drawpot and Miners - half head, around neck and horns are legal catch.**

c. All four feet must be within the stretch ropes; if a foot is lost it must be replaced in the rope.

d. Both front feet and both hind feet are the only legal stretch allowed before the calf is branded.

e. Ground crew can pick up a dropped head rope for the ropers without a penalty if the ground crew is back in the circle by the time the calf is heeled.

f. After the calf is heeled, a dropped head rope can be picked up by the ground crew without the ground crew going back to the circle.

g. After each calf has been branded, the calf must stand on all 4 feet before the next calf can be roped.

h. On the last calf, calf has to be on his feet and free of rope, the iron back in the fire and ground crew in the ring before the judge signifies final time. It is the team's responsibility to see that all cattle are up and free of ropes before they call time.

i. No persons but team and officials will be allowed in or around the arena. Only 2 horse holders allowed outside of pen. Failure to comply will be grounds for disqualification.

j. Once contest has started, there will be no discussion with the judges.

k. Time will only be called in the pen or pens that are affected by a fence down or an injured animal or contestant.

l. A lost rope must be returned to the original roper.

m. An Elko County Fair Board branding iron will be furnished.

## **5. PENALTIES:**

a. A penalty of 20 seconds will be applied for not walking to the edge of the herd for each calf.

b. A 30 second penalty per incident will be applied if the ground crew leaves the designated area before the calf has been headed and heeled.

c. A 30 second penalty will apply for a light brand.

d. There will be a penalty of 30 seconds per incident for a heavy or improperly placed brand.

e. A 30-second penalty will be applied for any iron that contacts the ground for any reason outside of the circle.

f. A 30 second penalty per incident will be assessed if a horse is ridden through the designated area as set by the committee.

g. A 30 second penalty after each calf has been branded, if the calf doesn't stand on all 4 feet before the next calf is roped.

h. A penalty of 90 seconds for undue roughness with the calves. A second incident of "roughing the cattle" disqualifies the team.

### **7. COMPETITION:** 12 minute time limit for Womens, Co-Ed, Open, Miners and Drawpot, 8 minute time limit for Youth and Senior divisions.

**Women's, CO-ED, Miner's & Drawpot** - will rope a total of (4) four calves. The (3) three fastest Women's teams will go to the finals. The top (6) CO-ED teams will go to the finals. A team will be disqualified if they do not rope and brand all 4 head. Times in the finals will be for that day only.

**OPEN** - will rope a total of (6) calves and the six (6) fastest teams will compete in the finals. Times in the finals will be on that day only. No average will decide the Open Incentive championship.

**YOUTH** - Top 3 teams from each age division will compete in the finals.

**SENIOR** - will not have eliminations.

### **8. FINAL DECISION & DISPUTES:**

The Elko County Fair Board Stockhorse Committee shall have the final decision on any disputes about entries, penalties, procedures, and event. In case of dispute, a team puts up \$50 to the stockhorse secretary; upon receipt the stockhorse committee will hear the complaint for a decision. If the committee rules in favor of the team the money will be returned if not the money is put into the pot. Any person desiring to file a complaint regarding any alleged violation of the rules may do so within an (1) hour of the completion of the event. (An event being eliminations, semi finals or finals). Rules of the judge and stockhorse committee are final. Any dispute with the judges will result in disqualification. See rule 3 page 8.

The **ONLY** legal catch is the head only. After the yearling is caught the rider must dally on a slick horn, stop, and then pull the yearling approximately ten feet. Failure to catch the yearling will result in breaking the pattern. This is not a timed event. The same horse, rider, and equipment must be used in this event as in the other three events in this class. You may change saddles, and breast collars are acceptable. This event counts 25% of the overall score.

Horses must meet eligibility requirements and owned by a Nevada resident. **Age-specific headgear**.
