Elko County Fair Board Chairman Tony Buzzetti called the regular monthly meeting to order at 5:35 p.m.

**Minutes:**     *Action Item*

Meeting Minutes from the Regular monthly meeting February 12, 2025. Jay Dalton moved to approve the meeting minutes as presented, Justin McDermott seconded the motion, all board approved.

**Board, Staff & Committee Vacancies / Appointments:**     *Action Item*

Chairman Tony Buzzetti welcomed the new board members Kameron Clifford and Justin Wines. There have been 2 that have applied for the stockhorse board position. Discussion on both applicants. Jay Dalton nominated Tyler Seal for the position John Ross seconded all approved.

**Livestock Committee Updates and Rule Changes:**     *For Possible Action Item*

Ben McKnight reported they will need Rayann Carroll as a rabbit committee member, Garrett Tomera as an at large person. The Camp for livestock kids, dates are set up at Camp Lee. It was organized at one time with our livestock committee. It doesn't need to come to the fairboard for anything. They can run it through just individual clubs and through the livestock committee. In the past, the funding for the camp was run through the clubs not through the livestock committee.

Jay Dalton moved to add the Garrett Tomera and Rayann Carroll to the committee Justin McDermott seconded. All approved. Tony abstained

Rabbit Judge Ray Stacey out of California \$300.00 per day and 2 nights in motel-Jay Dalton moved to hire the rabbit judge at the recommended rate. Justin McDermott seconded the motion. All approved.

Large animal judges are still in the works.

Replace 2 and possibly 3 full beef and 2 boxes of hamburger-Discussion on the prices. \$4.00/lb for hamburger and \$7.50/lb for the full beef price. Justin McDermott recommended replacing 3 full beef and 2 100lb hamburger boxes if the price is roughly \$14,300.00. Jay Dalton seconded the motion. Jay will contact Ida Meats to get this done. All approved.

**2025 Elko Co Fair Planning / Racing Parimutuel:**     *For Possible Action Item*

Discussion on the parimutuel machines and requirements and companies we are using. There are 2 options, United Tote and Sport Tek and we are waiting for them to get back to us.

**Grounds Reports and Improvements Update:**     *For Possible Action Item*

Grounds Manager Justin Reeves reported that the gate for the front entrance is \$1,700.00. Justin McDermott moved to purchase a front gate from Infinity fence and Cori Rainwater seconded. All Approved.

Working on the handicap ramp, area in front of the grandstands. 9' wide and the ramp would end at the asphalt, so they aren't in the dirt. It will seat about a dozen wheelchairs. It will be lower than the box seats but above the people standing at the fence. He wants to replace the spools too. He got all the teeth ordered for the ground machines.

Handicap parking during other events he wants in front of the arch to the house and during the fair along the back of the high school football field across the street from the arch. All the north barns have been without power for a long time, one electrical panel is totally fried. He will bring the amounts to the April meeting.
